This agreement, made this day of, 2023 by and between First Presbyterian Chur	ch Weekday
School (hereinafter referred to as the "School") and and and	
(hereinafter referred to jointly and severally as "Parents"), the Parents of	
referred to as "Child").	
For and in consideration of the promises and agreement hereinafter stated, the Parents agree to en	roll and the
School agrees to accept for enrollment the Child as a student at First Presbyterian Church Weekday	School for the
academic year beginning August 2023 and continuing until May 2024 (hereinafter referred to as th	e "Academic
Year"), and the parties agree that:	
1. In order to secure your child's enrollment, there is due and payable with this Enrollment Agreem	ent, (i) a
nonrefundable supply fee of \$100.00 due by March 1, 2023 and (ii) the first month's tuition (Septer	nber) in the
amount of \$ due by May 1, 2023, which will become nonrefundable after August 1, 2023.	
2. Parents will pay to the School the Child's tuition as follows (please choose one):	
• Tuition will be billed by semester in two equal installments of \$ on the 1st of September 1	mber and on the
1st of January, without prorating or offset.	
Or by monthly installments of \$ and will be billed on the 1st day of each calendar m	onth, September
through May, without prorating or offset.	
 For payments received after the 10th of each month, there will be a \$25.00 late fee per mont 	h until late
balance is paid in full.	
3. It is our intention to pay the School on a: Monthly Basis Semesterly Basis	
4. In the event that a Child withdraws August 1, 2023 or later, all payments made up to and includi	ng the month of
withdrawal are nonrefundable, and the Parents are obligated to pay the School an additional amoun	_
month's tuition.	1 0
5. In the event a payment of tuition is not paid within 2 months of its due date, the Weekday School	l may dismiss
your Child from the School in which event all unpaid tuition plus tuition for the then current month	=
immediately due and payable.	
6. Parents agree to pay any collection agency or attorney's fees pertaining to the Child's account.	
7. The School reserves the right to terminate the Enrollment Agreement for reasons of non-coopera	ation or inability
of Child or Parent to adjust to the School program, as determined by the Board of Directors and/or	the Director of
First Presbyterian Church Weekday School.	
This agreement shall become binding upon all parties upon its execution by the parties hereto both	jointly and
severally.
